Edgemont Ranch Metropolitan District Meeting of the Board of Directors Minutes

The Regular meeting of the Board of Directors of the Edgemont Ranch Metropolitan District was called to order on Tuesday, December 7, 2021 at 4:00 PM on Zoom.

All Directors were in attendance: Steve Martin, Al Winzerling, Larry Mongelli and Richard Butler. Staff members in attendance were: Robert Ludwig, Mike Lancianese, Eric Mietchen, Kurtis Martinez, Marilyn Heide and Annette Hutchins. Linda Herz also joined in on Zoom.

Mr. Winzerling moved to approve the October 21, 2021 ERMD Regular Board Meeting Minutes, seconded by Mr. Butler, and was unanimously carried.

Marilyn reviewed the 2022 Budget, Marilyn explained the higher cost of renting the loader for snow removal. We will be renting it for 4 months instead of three. Mr. Martinez added that Honnen Equipment does not do winter rentals anymore. We have to rent at the base price now - instead of \$3100/month, it will be about \$5100/month. They may credit us for one month's use if it's a mild winter like last year. It will cost about \$1800 more than previously proposed. Marilyn stated the debt payment for the new waste water plant is a close estimation. (See under capital outlay, page 3). She explained we will do filters in the water treatment plant and also piping for a third booster pump. Mr. Ludwig addressed these items. We had to have a booster pump, which supplies water from our lower tank to our upper tank in our storage distribution system, repaired this year. Metro purchased a third pump this year for a contingency backup. We will be paying for the piping early next year in January & February, and using the same pipe fitters that are fitting the pipe for our waste water plant to redo our booster pump station and add the third pump for redundancy. The upper tank supplies water to 2/3 of the subdivision. We are adding a separate filter train to the water treatment plant. It will do 350 gallons/minute - like our current filter, and is able to provide a consistent 1 micron Micro-filtration and will have zero water loss. When we encounter draught years we are able to operate our filters more efficiently when we are not able to lose water. It gives us a lot of options. It is in the budget as well. The cost of these items will be \$103K. Mr. Butler added he had long discussions with staff about the filters. The water savings justified spending that much money to put the filter system in place as soon as possible. It shows why we have to maintain a decent level of reserve in our water and sewer operation funds. He noted the rising inflation and how it has affected our roads operation budget for snow removal. Mr. Butler is reinforcing the need for a decent level of reserve in our major funds. Marilyn said these were the only changes in the 2022 preliminary budget proposal.

Mr. Butler moved to approve the Resolution to Adopt the Budget for 2022 (#2021-12-7.1), seconded by Mr. Winzerling and was unanimously approved. (See attachment)

Mr. Butler moved to approve the Resolution to Appropriate Sums of Money for 2022 for the general fund, water fund, sewer fund and the debt service (#2021-12-7.2), seconded by Mr. Winzerling and was unanimously approved. (See attachment)

Mr. Butler moved to approve the Resolution to Set Mill Levies associated with the roads (#2021-12-7.3), seconded by Mr. Mongelli and was unanimously approved. (See attachment)

Mr. Butler explained the auditor's increased fee to \$9000. The auditor hadn't raised his fee in several years. This is about a 10% fee increase. Mr. Butler noted Metro has more residents, and new debt financing to review. It is the lowest audit fee for our size and operation that he has seen in the area and considering the rising costs, and compared to other local auditor's fees it is a good deal. He said it doesn't require a resolution for him to sign the audit engagement letter. Mr. Martin

moved to approve the new fee for the auditor, seconded by Mr. Winzerling and was unanimously approved.

Marilyn had added the sick leave policy item, though she noted it actually had been previously covered.

Mr. Winzerling moved to approve the meeting dates for 2022 and was seconded by Mr. Butler. (The dates are: February 17, April 21, June 16, August 18, October 20, and December 8). Mr. Martin moved to approve resolution #2021-12-7.4 of the five Designated Posting Locations for ERMD meeting notices, and meeting dates for 2022 (also #2021-12-7.4), seconded by Mr. Butler and was unanimously approved. (See attachment)

Mr. Martinez gave a waste water plant update. Staff members continue to have the weekly meetings with Integrated Water Services. The slab on top of the foundation for the process building will be poured the week after next. On January 3rd the building supplier will erect the process building and the head works building. The lagoons have had 3 months of no violations. We are at 15.9 with a total of 16 on the total of inorganic nitrogen – when it gets cold we expect to get the failures/violations. The state realizes this will happen. Everything is going as planned. Mr. Martin asked if we can be substantially interrupted by bad weather. Mr. Martinez explained that it should be OK as long as the storms are small. He added as long as the slab gets poured on the foundation on January 3rd, it should be fine.

Mr. Ludwig related that David McMahon, who works for EPOA, had been using the Metro's RTV until this past year. Mrs. Herz, EPOA President, confirmed that Mr. McMahon was not using the RTV anymore, he was using his own truck for various tasks. Mr. Martin agreed, Mr. McMahon should discontinue use of Metro's RTV.

Mr. Butler moved to keep the Metro Board officers the same for 2022, seconded by Mr. Winzerling and was unanimously approved. (Steve Martin – President, Larry Mongelli – VP, Richard Butler – Sec/Tres, Al Winzerling and Andrew Rapiejko – Directors)

Mr. Martin appointed Marilyn Heide as the designated election officer for the Metro.

Mr. Butler had a concern about a rough area on Edgemont Highlands Blvd. He was worried that snow plowing would worsen this road condition. It had been budgeted for repair this year. Mr. Martinez explained he had called Leeder to see if they could patch the pothole enough to get through the winter, but they were so backed up they hadn't been able to. If they aren't able to come, staff will do a temporary repair job, then Leeder will make a permanent repair in the spring. Staff will keep the board posted on this road issue.

Mr. Martin moved to adjourn the meeting, seconded by Mr. Winzerling at 4:25 PM.

The Board then adjourned into executive session for the purposes of personnel evaluation and compensation pursuant to Sec, 24-6-402 (4)(f), C.R.S. at 4:38 PM.

The Board re-convened the public meeting. After reconvening the public meeting, the Board unanimously approved the report of the Compensation Committee which will govern the balance of 2021 and the commencement of 2022. Thereafter the meeting was adjourned.

A RESOLUTION LEVYING GENERAL PROPERTY TAXES FOR THE YEAR 2021, TO HELP DEFRAY THE COSTS OF GOVERNMENT FOR THE EDGEMONT RANCH METROPOLITAN DISTRICT, COLORADO, FOR THE 2022 BUDGET YEAR.

WHEREAS, the Board of Directors of the Edgemont Ranch Metropolitan District, has adopted the annual budget in accordance with the Local Government Budget Law, on December 7, 2021; and

WHEREAS, the amount of money necessary to balance the budget for general operating purposes from property tax revenue is \$257,008; and

WHEREAS, the amount of money necessary to balance the budget for bonds and interest is \$62,897; and

WHEREAS, the 2021 valuation for assessment for the Edgemont Ranch Metropolitan District as certified by the County Assessor is \$32,640,090.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE EDGEMONT RANCH METROPOLITAN DISTRICT, COLORADO:

That for the purpose of meeting all general operating expenses of the Edgemont Ranch Metropolitan District during the 2022 budget year, there is hereby levied a tax of 7.874 mills upon each dollar of the total valuation for assessment of all taxable property within the District for the year 2021.

That for the purpose of meeting all bonds and interest of the Edgemont Ranch Metropolitan District during the 2022 budget year, there is hereby levied a tax of 1.927 mills upon each dollar of the total valuation for assessment of all taxable property within the District for the year 2021.

That the Controller is hereby authorized and directed to immediately certify to the County Commissioners of La Plata County, Colorado, the mill levies for the Edgemont Ranch Metropolitan District as hereinabove determined and set.
